## Collection of Personal Data:

- 1. Through the hiring of Revhram's services: Details the collection of personal data when hiring services, including objectives and types of data.

#### Legal Basis for the Processing of Personal Data:

Sharing of Personal Data:

Restricts access to authorized professionals and shares data with financial institutions. May share data in specific cases, such as legal compliance, merger, acquisition, among others.

Storage of Personal Data:

Data is stored in secure environments by Revhram, respecting legal deadlines. They may be stored by contracted third parties and in the cloud, following security standards.

Sensitive Personal Data:

The collection of such data is done strictly when necessary, with a legal basis and prior consent.

Processing of Personal Data of Children and Adolescents:

Carried out in accordance with legal requirements and authorization from parents or legal guardians.

International Transfer of Personal Data:

Adopts measures to ensure adequate protection in international transfers of data.

Exercise of LGPD Rights:

Data subjects have rights such as confirming processing, access to data, correction, anonymization, blocking, or deletion, temporary suspension, information on data sharing, revocation, and portability.

#### What are Cookies?

Cookies are small files downloaded by the website on your device to improve your experience and may contain personal data. The cookie allows the website to "remember" your actions or preferences over time.

# What are the types of collected Cookies?

Functional Cookies: Storage or technical access is strictly necessary for the legitimate purpose of allowing the use of a service explicitly requested by the user or for the sole purpose of transmitting communication through an electronic communications network. The legal basis for this processing is Legitimate Interest, and the data will be kept for the necessary period to fulfill the purpose. At any time, the user can delete cookies in their browser.

Statistics Cookies: Storage or technical access is necessary to collect data and information about how users use the site, which pages they visit most frequently on that site, the occurrence of errors, or information about the site or application's performance. The legal basis for this processing is Consent given in the cookie banner. This consent can be revoked at any time by accessing the cookie banner. The data will be kept for the necessary period to fulfill the purpose. At any time, the user can delete cookies in their browser.

Marketing Cookies: Storage or technical access is necessary to create user profiles to send advertising or to track the user on a site or across multiple sites for similar marketing purposes. The legal basis for this processing is Consent given in the cookie banner. This consent can be revoked at any time by accessing the cookie banner. The data will be kept for the necessary period to fulfill the purpose. At any time, the user can delete cookies in their browser.









How do I delete cookies on my device?

You can disable and delete cookies in your browser. However, this may affect your access and the functionality of the site. All browsers allow you to configure how they work with cookies. Access your browser's settings function to make this change.
